- Ensures Environmental Management System (EMS) meets requirements of ISO 14001, reports performance of EMS to management, maintain 14001 certification
- Completes all Federal, State, Local and corporate regulatory reports
- Maintains environmental, health and safety policies/procedures
- Responsible for investigating workplace injuries/illnesses. Prepares report and recommends corrective action.
- Reviews workstations for ergonomic improvements. Suggest changes to equipment, processes and facility to improve safety
- Oversee hazardous waste program; maintain inventory, schedules pick-ups, maintain documentation and performs state reporting
- Ensure proper PPE is available and used properly
- Maintain monthly safety meetings and follow up on items listed as non-compliant
- Provide safety training including new hire orientations, blood borne pathogens, lockout/tagout, PPE, fire extinguisher, hazard communication and others
- Conduct hazard evaluations, and other exposure assessments as needed
